for fire-fighters

Special protective actions : Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. Small spill

7.1 Precautions for safe handling

8.2 Exposure controls

Appropriate engineering controls

Individual protection measures

Hygiene measures

: Wash hands, forearms and face thoroughly after handling chemical products, before eating, smoking and using the lavatory and at the end of the working period. Appropriate techniques should be used to remove potentially contaminated clothing. Contaminated work clothing should not be allowed out of the workplace. Wash contaminated clothing before reusing.
